Mr. Williams motioned to approve the proposed Meeting Agenda; seconded by Mr. DeLoach and unanimously approved 4-0.

Mr. Williams motioned to approve the Minutes from the September 9, 2020 Regular Monthly Meeting, as presented; seconded by Mr. DeLoach and unanimously approved 4-0.

Action Items

Holiday Landscape Enhancements

Following an overview by Mr. Allen, Mr. Williams motioned to authorize the Executive Director to execute documents between GPCID and Russell Landscape for landscape improvements at the Pleasant Hill Road over I-85 diverging diamond interchange, mulch enhancements throughout the district, and removal/replacement of landscape elements at the four quadrants at Steve Reynolds Boulevard and at Pleasant Hill Road along I-85 for an amount not to exceed \$17,750.00; seconded by Mr. DeLoach and unanimously approved 4-0.

Venture Drive/Day Drive Roundabout Landscape Enhancements

Following an overview by Mr. Allen, Mr. Williams motioned to authorize the Executive Director to execute documents between GPCID and Russell Landscape to enhance the streetscape landscaping at the Venture Drive/Day Drive roundabout for an amount not to exceed \$9,750.00; seconded by Mr. Wiener and unanimously approved 4-0.

2021 GPCID/Gwinnett County Leadership Strategic Planning Session

Following an overview by Mr. Allen of the proposed timeline, discussion topics, goals and attendees for the April 14, 2021 strategic planning session, Mr. Williams motioned to authorize the Executive Director to execute documents between GPCID and Plan Your Steps, LLC for strategic planning services for an amount not to exceed \$9,652.50; seconded by Mr. DeLoach and unanimously approved 4-0.

Treasurer's Report

Mr. Allen noted, as of October 31, 2020, the GPCID had approximately \$953,000.00 in cash. He encouraged board members to review the monthly financial summary and expenditures for September and October 2020. The current cash balance and expected revenues leave an estimated \$1.6 million available at the board's discretion through the end of the GPCID lifecycle ending in 2023.

Mr. Williams motioned to approve the Treasurer's Report and ratify the expenditures; seconded by Mr. Yorker and unanimously approved 4-0.

Mr. Wiener recognized the veterans in the audience and thanked them for keeping the spirit of America alive. He looks forward to working with Gwinnett's newly elected leadership to move the Gwinnett Place area forward.

Executive Director's Remarks

 Mr. Allen reviewed three 2021 O&M budget scenarios. A staff-recommended budget will be submitted to the board for consideration/adoption at the December meeting.

- Lt. Larry Stone, Gwinnett County Police Department, Technology Support Unit, provided an overview of the Gwinnett County Police's Situational Awareness and Crime Response Center.
- Ms. Maggie McDaniel, communications 21, provided an overview of the various media outreach efforts, social media analytics and earned media regarding GPCID initiatives.
